Funeral services for William Alvin Moore, 37, vice-president and general sales manager of the Mississippi Power and Light company, who died yesterday at a local hospital, will be conducted from Galloway Memorial Methodist church this morning at 10 o'clock.

The body will lie in state at the J. S. Love home 932 North State street, until the hour of services to be conducted by Dr. B. L. Sutherland and Dr. W. A. Hewitt with interment in Lakewood Memorial Park.

He had been ill two weeks and passed away quietly at 8:30 Monday morning after taking a turn for the worst late Sunday night. The general offices of the power

company in the Lampton building, where Mr. Moore rose to the high position of vice-president, will be closed today up until the noon hour after the funeral.
